CCA's advocacy efforts have:

- Stabilized community college funding through Proposition 98, which guarantees education dollars to community colleges every year.
- Won monumental increases in CalSTRS benefits for our members.
- Secured part-time healthcare benefits and re-employment rights legislation.
- Expanded the number of full-time faculty statewide.
- Designated funding for part-time faculty health benefits and office hours.

PART-TIME FACULTY VICTORIES

As the driving force advocating for part-time faculty compensation, health insurance, and paid office hours, CCA is committed to achieving equity for all part-time faculty.

Here are just two ways we are leading the fight:

- AB 190 expands current part-time faculty health insurance programs and incentivizes districts by providing up to 100% reimbursement for healthcare costs. This empowers CCA local unions to bargain expanded access to healthcare benefits for part-time faculty.
- We worked together in our union to file a class action lawsuit against Long Beach City College (LBCC) for failure to pay minimum wages to over 900 part-time faculty for their out of classroom work. This class action lawsuit was successful and established a new legal precedent, sending a message statewide that part-time faculty must receive fair and just compensation for their out of classroom work.
