I left those meetings absolutely impressed by the commitment, creativity, and urgency our board brought to the table. This is not just an event, it is a call to action.

And action is exactly what this moment demands. This is why I was proud to work in conjunction with our REAC Directors to draft and release a statement that **unequivocally condemns the arrest, harassment, and intimidation of students, families, and their advocates by ICE and federal forces**. These acts are direct violations of human dignity, civil rights, and the fundamental right to education. As educators, we will not stand by while our communities are attacked, we will act.

It was also an honor to visit San Diego State University on September 24th, where I met with members to share about our statewide work, and together we launched the start of my Banned Book Raffle (congratulations again to the winners). To see future educators so engaged, ready to organize, ready to defend public education, and ready to uplift our communities was a reminder of why this movement is so urgent and so necessary.





Chapter Development Updates

The 2025–2026 academic year is off to a powerful start for CTA-Aspiring Educators (CTA-AE)! I am honored to serve as your Executive Vice President, supporting Chapter Development and Membership Recruitment across two- and four-year colleges and universities. The following updates reflect the energy, commitment, and impact we are creating together.

Executive Leadership and Board Meetings

Our first CTA-AE Board Meeting was held in person on August 16–17, 2025, at the California Teachers Association Headquarters in Burlingame, California. We reconvened at the same location on September 20–21 to assess progress and strategize for the year ahead.

The current CTA-AE Executive Board consists of our President and myself as Executive Vice President, while the Secretary-Treasurer position remains vacant. We are actively recruiting to fill this important leadership role. Despite the vacancy, our momentum has not slowed. In partnership with our regional leaders, we have made significant strides in chapter development and membership recruitment across campuses in the state of California.

National Engagement: NEA State Leaders Retreat

On September 6 and 7, I had the distinct honor of representing the state of California at the first-ever **National Education Association (NEA)** State Aspiring Educator Leaders Virtual Retreat. Over two days, leaders from across the 50 states convened to sharpen strategy, deepen coalition, and strengthen our shared commitment to advancing educator leadership nationwide.

As part of the program, I was invited to present an overview of how CTA-Aspiring Educators in California structures, supports, and elevates emerging leaders within the profession. The presentation was well received and resonated beyond state lines, so much so that one of my remarks was later quoted and featured on the official NEA Aspiring Educators (@neaspiringed) Instagram page. It was a powerful reminder of the reach and relevance of our collective work.

This experience was both humbling and energizing. It underscored how essential it is to not only be present in national spaces, but to meaningfully contribute to the dialogue shaping the future of education.

Chapter Development and Membership Engagement

Our outreach has been both intentional and adaptive—blending grassroots engagement at pop-up events, one-on-one Zoom meetings, phone calls, text communication, and a consistent social media presence. The response from students and campus communities has been overwhelmingly positive, and early indicators suggest we may even surpass our ambitious membership goals this year.

This momentum is a powerful testament to the dedication of our leaders, many of whom are balancing multiple roles and personal responsibilities, yet remain deeply committed to advancing CTA-AE's mission: to build a strong, inclusive, and informed community of future educators.

Regional Highlights: Growth Across Campuses

In my interim and additional role supporting **Region 3** (the Region 3 Director position is currently vacant), outreach has been initiated with several campuses, including:

- Pasadena City College
- California State University, Northridge (CSUN)
- California State University, Channel Islands
- Western Governors University (WGU)
- San Bernardino Valley College – engagement led by our CTA-AE President, with plans to recharter
- University of California, Santa Barbara

Meanwhile, in **Region 4**, re-engagement with the University of California, Irvine is well underway. CTA-AE President Gabriel Mendoza and Region 4 Director Giselle Reyes recently met with the Teachers of Tomorrow Board Officers on Tuesday, September 16, to discuss club charter at this campus. Southwestern College has also expressed interest in forming a chapter.

In even more exciting news from Region 4, Irvine Valley College has confirmed to me that a newly formed Executive Leadership team is in place for the 2025–2026 academic year and is currently awaiting official club ratification. On September 16, the campus hosted a Teacher Preparation Pathway (TPP) event, which I had the privilege of attending, welcoming esteemed guests from:

- Santiago Canyon College
- UCI CalTeach
- Saddleback College
- Cerritos College


TPP's mission to "create a supportive and accessible hub for teacher pathway students, guided by data and informed by student needs" directly aligns with the values we uphold at CTA-AE.

Regional Directors in **Region 1**, **Region 2**, and **Region 4** have also shared promising developments in chapter engagement. We look forward to highlighting their continued work in future updates.

Chapter Roundtable Meetings

I am thrilled to announce the first **Chapter Roundtable Kickoff Meeting**, scheduled for **October 3, 2025, from 2:00 PM to 3:00 PM Pacific Time**. These monthly virtual gatherings will serve as a collaborative space for chapter leaders to connect, exchange strategies, build community, and strengthen our collective impact.

3. Show proof of elected leadership, ie: Chapter President;
4. Show proof of at least one advisor, ie: faculty in your campus School of Education; and
5. Share your governing documents, ie: Chapter By-Laws – we have samples you can use!

CTA-AE Chapter & Member Spotlight

Spotlight: Sara Huerta (CTA-AE REAC Director) at Irvine Unified School District

Sara Huerta recently began a new position as a classroom aide with the Irvine Unified School District, working as a paraeducator in the Essentials program, which supports students with special needs. As she spent time getting to know her coworkers, she quickly noticed a surprising trend: many of the classroom aides—despite being aspiring educators themselves—were unfamiliar with CTA-AE (California Teachers Association – Aspiring Educators). Recognizing a missed opportunity to connect these future educators with valuable resources, support, and professional development, Sara began developing an idea to raise awareness. She is currently working on creating presentations and informational flyers to share more about what CTA-AE offers and why it's such an important resource for aspiring teachers.

Sara shared her idea with one of her supervisors, who was already familiar with CTA and CTA-AE but admitted she had never considered that aides who are also students might not be aware of the union or its benefits. After a meaningful discussion, the two agreed that this was a valuable initiative and decided to collaborate on a strategy to reach more aides across the district. Their goal is to expand access to professional opportunities, resources, and networking for all aspiring educators within the Irvine Unified School District. Through this initiative, Sara hopes to empower more future teachers with the knowledge and tools they need to succeed—and to build a stronger, more connected educational community.

State Council Representative Updates

Hello CTA-AE Members!

We hope you all have had a wonderful start to your semester!

This month, the CTA-AE Statewide Board met, where State Council Representatives introduced the Statewide Board to Propositions 50 and 55.

Proposition 50 is an emergency response to partisan redistricting in Texas that allows California to temporarily redraw congressional districts to give students and teachers a fighting chance at the federal level. Districts would return to those drawn by an independent commission after the 2030 census.

Proposition 55, an extension to Proposition 30, seeks to secure the existing funding available to K-12 public schools and community colleges. A failure to extend this Proposition would lead to devastating cuts to our schools, leading to a loss of over \$9 billion in funding. As you all continue your academic year and begin to reconnect with your local Aspiring Educators' chapters, we urge all of you to keep this proposition in mind and begin to think about how we all can organize together to collect signatures to ensure this proposition is on the ballot next year.

On the weekend of October 17-19, State Council Representatives will be traveling to Los Angeles to set forth policy, develop legislation, and make recommendations in the general elections. As we prepare to be in our assigned council, we are excited to represent all of you in our voting. We are eager to bring back information on what we have accomplished so that you may share it with your Aspiring Educators.

REAC Director Updates

In response to the rise in attacks against immigrants across the United States, the CTA-AE Board adopted the following statement during the September CTA-AE Statewide Board Meeting. This powerful statement was crafted through the creativity, thoughtfulness, and critical insight of our REAC Director, who played a key role in shaping its message and impact.

1. Unequivocally condemns the arrest, harassment, and intimidation of students, families, and their advocates by ICE and state forces, recognizing such actions as direct violations of human dignity, civil rights, and the right to education.
2. Recognizes and urges the protection of aspiring educators, faculty, and students, especially immigrant and undocumented students, who face targeting or retaliation for standing up for justice.
3. Supports and encourages our student organizations to work in conjunction with their communities to ensure that all educational spaces remain safe, supportive, and free from fear.
4. Demands local, state, and national leaders end ICE and targeted enforcement and to create safeguards which protect the safety and integrity of our immigrant students, their families, and their advocates.
5. We would like to give you a quick update on the Resource Hub we mentioned in the last newsletter. The resource hub is still under development, and we plan on premiering this tool at the Fall 2025 Conference on November 8-9!

JK had the opportunity to attend CTA's Special Education Conference, where they had the opportunity to reflect, learn, and strategize with other educators around equity, accessibility, and the collective power in our schools and union. Keynote speaker, Jesse Goss, stressed the importance of documentation. Whether it's advocating for students, defending our rights, or navigating compliance, accurate and consistent data remains a powerful tool for us to have. She shared several resources and ideas, which will be going into the Resource Hub to be shared with everyone. The Individuals with Disabilities Education Act (IDEA) benefits all students, and protecting IDEA and its funding is a fight for equitable education and a critical issue for everyone in public education. Use the QR code below to urge senators and representatives to fully fund IDEA.



Fulfill the Promise of the Individuals with Disabilities Education Act

Special education addresses our most vulnerable students' unique needs.

Urge your senators and representative to support the IDEA Full Funding Act (S. 2177/H.R. 2598) to give all students the support and attention they deserve.



Finally, one of the most important takeaways was the importance of making our union spaces more inclusive. In line with our CTA-AE mission, we are considering barriers, both visible and invisible, that may be preventing full participation and how we can begin to dismantle them. Feel free to reach out and call out any barriers to your participation in our union. Together, we can continue to build our union to be stronger, more inclusive, more informed, and more united than ever.
