PRESIDENT'S PERSPECTIVE SUMMER 2022

o much has happened since the last edition of our ADVOCATE. Yes, our annual CTA/NEA-Retired Issues Conference did occur in March in what, I hope, is the last virtual only version of that event. With CTA, we will explore hybrid possibilities. Yes, CTA/NEA-Retired officers did attend the NEA-Retired Annual Organizing Conference in Baltimore in late March. It went well and was a lesson on "how to navigate through a multitude of Covid precautions." Being there, talking and sharing with other state leaders in the nation, was an eyeopener. It revealed to me that California and CTA/NEA-Retired are in many ways ahead of other states in continuing with our union activity, helping Active and Retired members, being politically active, and supporting public education.

Speaking of politics and lawmaking, CTA/NEA-Retired has been in the vanguard of those in the state and nation advocating for law

changes that directly affect retirees. We have called upon all members with direct email alerts to contact U.S. Senate and House members to support H. R. 82 and H. R. 5723. Our RAN system (Retired Action Network) has been activated multiple times also to lobby in support of these measures to repeal the Social Security penalties of GPO/WEP. H. R. 5723, in particular, includes a means to fund the repeal. Keep in mind: Elections matter! There is resistance from one party. The success of these bills depends on how the midterm elections go.

At the California state level, we have also been putting on a full-court press to get SB 868 and AB 1667 passed. As I write this now, the two bills have passed both Houses and are on the Governor's desk. For more information about SB 868 and AB 1667, see the CTA State Council Year-End Review article on this page. CTA/NEA-Retired has been working doggedly with CTA Legislative Advocates to move these bills forward. Again, elections and politics matter.

I have met with many Active chapter leaders and members. At the closing of this 2021-2022 school year, it is apparent that teachers and other educators are exhausted. We suspect the number retiring will be higher than normal. We always attempt to make contact with all

CTA STATE COUNCIL YEAR-END REVIEW

In our January edition, we wrote about how the tenaciousness of your CTA/NEA-Retired leadership has paid off; that after years of our advocacy, CTA approved sponsoring legislation that will dramatically help members. Since January, a lot has happened!

The first piece of our sponsored legislation is SB 868 authored by Dave Cortese, the Chair of the Senate Labor, Public Employment and Retirement Committee. SB 868 is a proposal for CalSTRS to use the surplus monies in the Supplemental Benefits Maintenance Account Program for the benefit of members retired the longest. Those who retired prior to 1999 will get an increase in payments according to what year they retired.

The second piece of sponsored legislation is AB 1667 authored by Assemblymember Jim Cooper, Chair of the Assembly Public Employment and Retirement Committee. AB1667 would change how CalSTRS recoups monies that have been overpaid to retirees. Currently with the CalSTRS Overpayment Recovery Program, members who have been overpaid benefits are obligated by law to not only have their benefit reduced, but also to repay to CalSTRS any overpayments - even when the overpayment is due to a mistake made by their district or CalSTRS. The error could result in a retiree being notified that they owe thousands of dollars. Among other improvements, this legislative proposal would make districts and CalSTRS responsible for any overpayment recoveries. No member should have to pay for mistakes made by others!

Your CTA/NEA-Retired leadership and our State Council members worked with our CTA Legislative Advocate, Seth Bramble, to find CTA/NEA-Retired

BOARD REPORT by Debra Sheehan, Secretary-Treasurer

CTA/NEA-Retired Board of Directors Meeting March 25, 2022

Action Items:

The following items were approved: to extend the \$300 Chapter Assistance Program from August 31 to December 31, 2022; to support the actions of President Garrison regarding North Bay Retired requests; and to encourage Retired Locals to do continued outreach.

Informational Items:

- CTA Vice President David Goldberg stated that the 2022 Initiatives look good for education, School Board elections are a way to identify opposition and candidates to support, and that CTA is looking at technology to improve hybrid meetings. He also discussed racism and anti-vaccination, anti-mask, and anti-trans students' issues.
- CTA Executive Director Joe Boyd introduced our new Executive Deputy Director Laura Kurre. Laura and Joe were urged to keep CTA/NEA-Retired involved in political campaigns and activities. Joe discussed the importance of School Board elections and ways to stay involved with Locals.
- President Orval Garrison announced election results, which are posted on our website. Our three current officers, Regional Alternates, and NEA Representative Assembly delegates were elected. He announced that Local Chapter Presidents' Outreach virtual meetings are planned for April and May. Orval reminded attendees of \$300 Chapter Development Fund that has been extended through the end of 2022. He updated us on the progress of the Workgroup, which is finalizing Bylaws and Standing Rules proposals, updating materials, and reworking our website. Orval discussed H.R.82 and H.R.5723 (GPO/WEP elimination). Local outreach and virtual meetings were encouraged. Discussion was held about efforts to identify members who drop after their one-year gift membership. Solutions are being pursued.
- CTA Legislative Advocate Seth Bramble spoke about AB 1667 (STRS repayment) and SB 868 (Supplementary Benefits Maintenance Account). A discussion was held about the pros and cons of fossil fuel divestment. Seth also talked about AB 1877, which would

- change earnings limitations for Special Education teachers.
- CTA Staff Rose Luna reported that virtual Retirement Workshops, presented by Service Centers, have been well-attended. She expressed her goal to open these virtual workshops to all. Rose stated that our CTA/NEA-Retired brochures are part of these workshop materials.
- CalSTRS Board Member Denise Bradford said that she is on the CalSTRS Appeals Committee which hears appeals from members having to pay back CalSTRS overpayments and other appeals.
- Vice President Dana Dillon reported that the May 3, 2022 Webinar about retirement issues will be targeting members aged 50 plus and that the spring membership effort will ask Active CTA Chapter Presidents to submit retiree's names to their CTA Staffperson.
- Secretary/Treasurer Debra Sheehan reported that our membership has increased by 1,024 since February 21, 2022, and now totals 20,012. The Russo Scholarship balance is \$10,968. The Pedretti Scholarship balance is \$125,000, with four planned awards of \$1,500 each this coming year -- one per region. The issue of continuous dues had been discussed with CTA and will be further discussed at this summer's CTA/NEA-Retired Board Planning Meeting.
- Board Members reported on activities in their regions and membership growth efforts. Bonnie Shatun discussed three ballot initiatives that we have been watching which would threaten public education. They did not garner the required signatures and will not be on the November 2022 ballot. She stated that we should start planning for their return in 2024. Retirees will again be called upon for participation.
- CTA Staff Consultant Brian Stafford asked for volunteers for the Commission on Professional Competence Panels (dismissal hearings). Retired members are eligible to serve on these panels up to seven years after retirement.
- NEA Board Member Ed Foglia provided information about the NEA-Retired Annual Meeting, June 29 30, 2022 and the NEA Representative Assembly July 3 6. He urged participating in the \$5.00 a month Cup of Joe Campaign for the NEA Fund.

BOARD REPORT AND ANNUAL BUSINESS MEETING

CTA/NEA-Retired Board of Directors Meeting January 14, 2022

Action Items: At the Board Meeting, the proposed Bylaw changes and the proposed 2022-2023 budget were approved to send to the Annual Meeting, the Standing Rules were approved, and the Russo Scholarship recipients were announced and approved. At the General Membership meeting, Bylaw changes, 2022-2023 Goals, proposed 2022-2023 Budget, and the formation of a Budget Committee were approved.

Reports:

- 1) CalSTRS Chair Harry Keeley and Board Member Denise Bradford thanked us for our institutional knowledge and participation. Harry mentioned that CTA member Ken Tang was appointed to the CalSTRS Board. Denise talked about the Fossil Fuels Divestment issue and why STRS believes in "engagement, not divestment." They are working on short term climate goals and accelerating the move away from fossil fuels.
- 2) President Orval Garrison announced that our new brochure is coming out soon and that the Workgroup continues to work on updating our website. He presented the Board approved 2022-2023 CTA/NEA-Retired Goals, which the General Membership also approved.
- Orval announced the two 2022 Russo Scholarship winners are Joshua Ayala and Jessica Riojas. The new Pedretti Scholarship will start recipient selections later in August. He reviewed the driving efforts of CTA/NEA-Retired on CalSTRS and legislative effort for SB 868 (Supplementary Benefits Maintenance Account) and AB 1667 (Pension Overpayment). 4) Vice President Dana Dillon reported that CTA/NEA Retired Membership Webinars are in their second successful year. Virtual Regional Outreach has been completed for Regions 3 and 4, with Regions 1 and 2 to be scheduled. Dana summarized our CTA/NEA-Retired collaboration with CTA Legislative advocates and told of requested actions to support California bills about retirement. She announced plans to update our Retired Action Network (RAN) lists by legislative districts. Dana updated us about the new NEA Membership award.
- 5) Secretary/Treasurer Debra Sheehan reported that our membership has increased by 1,064 from April 2021 to April 2022. The Russo Scholarship balance is \$11,118.00. The Pedretti Scholarship balance is \$125,000.00. Debra presented the proposed 2021-2022 Budget. The motion passed at the Board Meeting and the budget was referred to the Annual Meeting, where it was

- described for each region. Bonnie Shatun discussed CTA and CTA/NEA-Retired organizing efforts. Mary Rose Ortega spoke about monthly CARA meetings.
- 8) NEA Board Member Ed Foglia discussed the Social Security Fairness Act (H.R. 5723) that is currently in the House Ways and Means committee. This bill would repeal the WEP/GPO penalties for teachers and other public employees. Ed feels that this is our best chance to pass this long lobbied for issue because the bill includes a funding source. He asked us all to help. Ed also announced that he is running for re-election to the NEA Board.
- 9) Discussion Items: Dana discussed a group of members who are videotaping conference presenters and trying to undermine CTA activities. The General Membership approved the Board-recommended creation of a Budget Committee.
- 10) **Information Items:** The next Board Meeting will be held Friday, October 21, 2022 at the Westin Bonaventure in Los Angeles. Like us on Facebook: www.facebook.com/ ctanearetired (no "membership" in Facebook required).

CTA Retired President Orval Garrison reviewed the year's many accomplishments, gave CalSTRS and CalPERS updates, and shared tips to have a fun and secure retirement. BV-R President Carol Mathews asked for speaker and field trip suggestions. At the end, those in person gathered at the large screen to visit with friends attending by Zoom.



NEWS FLASH! Social Security Offsets ALERT!

Friday, July 15th was a historic day! For the first time ever, legislation to repeal the onerous Social Security Offsets will be moved to the floor in the House of Representatives! House Rules mandate that a bill that has 290 co-sponsors must have a floor vote. Last Friday, House Resolution 82 (HR 82) was filed with 291 co-sponsors by its authors Representatives Davis and Graves. This is the farthest any legislation to repeal the offsets has gone.

Members should continue to push their House Representatives to vote yes on HR 82 when it comes to the House floor for a vote, which could happen as early as late August or September.

Attention also now shifts to urging Senators to vote on Senate Bill 1302 (S 1302) which is the Senate companion bill to HR 82. S 1302, introduced in April of 2021, is stuck in the Senate Committee on Finance. While both California Senators Feinstein and Padilla have signed on as co-sponsors, contacting them and urging them to move the bill out of committee and to the Senate floor would be welcomed.





CTA President E. Toby Boyd addressed the Friday morning session and said that retired members are a vital resource for CTA. He thanked us for our activism on many issues important to our schools including supporting Proposition 15 and opposing the recall of Governor Newsom. Keeping our members, students and families safe is always our priority. CTA has also been on the front lines advocating for vaccinations, testing, improved ventilation and other measures to keep virus cases down in our schools. He pledged that CTA would continue to be the leader in advocating for CalSTRS and CalPERS.

President Boyd also spoke about the work CTA is doing to promote the concept of Community Schools. It begins with meeting with community stakeholders to ask what's needed so each child has their best education experience. Services available should include educators, nurses, counselors and social services to support students and their families.



Mary Kusler, NEA's Senior Director for Advocacy, reported on the positive impact of NEA's Day of Action to end the unfair tax on educator retirements by repealing GPO/WEP. These penalties affect more than 700,000 educators, mostly women who would be losing their entire spousal benefit. It also penalizes 1.9 million who worked in other jobs. NEA is supporting two bills and Mary said she is seeing actual movement for the first time. Under the Biden administration, education is receiving the largest financial investment in history and, that as she was speaking, the first African American woman, Ketanji Brown Jackson, was meeting with Senators in preparation for her confirmation vote. She closed by stressing that elections do matter and we cannot sit this one out. Our democracy itself is at risk.

CTA/NEA-RETIRED'S 18TH ANNUAL **ISSUES CONFERENCE MET VIRTUALLY**

Issues Conference was held on March 3-4 and once again was virtual due to COVID-19 concerns. The 278 participants had the opportunity to watch the sessions live or view any of the sessions online during the two weeks following the conference.

NEA-Retired President Sarah Borgman addressed the group from her home in Indiana. She shared that retired members make up 10 per cent of NEA's membership and contributed one fourth of the political contributions that NEA collected last year. She acknowledged that these are challenging times but our schools are the last, best hope for our Democracy and we as leaders must never remain silent. CTA President E. Toby Boyd and Mary Kusler, NEA's Senior Director for Advocacy, also addressed the Conference. (See side insert.)

One of the elective sessions I Landscape" given by Michael Borges, CTA's Political Action Manager. He reviewed the statewide initiatives currently in signature gathering and shared the wonderful news that the two Voucher Initiatives were unlikely to have enough signatures to qualify them for the November ballot but urged us to get ready for the fight because they may roll over to the 2024 general election. Up for election in California this November are our eight Constitutional Officers (including Superintendent of Public Education Tony Thurmond), one U.S. Senate seat (Senator Alex Padilla), 52 Congressional seats, 100 State Assembly and State Senate seats, as well as County Superintendent and Board of Education positions. Members are urged to go to www. cta.vourvoter.guide for a list of candidates where you live that are recommended and for CTA positions on upcoming ballot measures.

I also attended a wonderful session on Cyber Security Basics given by CTA Staffperson Elyse Dixon. She said that

This year's CTA/NEA-Retired security breaches and Ransomware are projected to cost more than \$6 trillion annually and to be careful using sites that can't be verified. She suggested hovering over links to see if they're actually coming from a trusted source like a favorite news site and beware of clicking on pop-up ads. A few more tips she gave are: 1. Analyze all incoming communications. 2. Verify the sender by hovering over or double clicking on the sender's email address or hitting the reply button to show the actual email address, 3. Logos are easy to copy. Be suspicious of content that has bad spelling, is asking for personal information or for you to do something urgently. 4. It's OK to open an email to look but think before you click on links or attachments. She also advised only going to secure sites that start with https - the s is for secure, stop using Internet Explorer and be sure your passwords are different, long and strong or use a Password Manager. Elyse is available to present similar workshops for our Retired Chapters. She can be reached at EDixon@cta.org.

> Sessions were also offered on CalSTRS, Travel Tips, Member Benefits, Extremist Activities, Medicare, Your Rights in the Hospital, Community Schools, Clutter Cleaners, and more. Do plan to attend next year's CTA/NEA-Retired Issues Conference scheduled for March 16-17. We will be working with CTA and hope to hold a hybrid conference to allow members to attend in person or participate virtually.

"SPRING INTO ACTION: DECLUTTER, DECOLONIZE, ORGANIZE" SETS THE TONE FOR CTA'S EQUITY AND HUMAN RIGHTS CONFERENCE

he 2022 CTA Equity and Human Rights Conference was held on March 4-6th at the Los Angeles Bonaventure Hotel. The conference began with a Welcome Reception and Dinner. Vice President David Goldberg spoke about the historical content of what has happened in the last two years and how it impacted our country and our communities. Another issue he discussed was how labor union rights and middle-class rights have been decimated. Our union has gone from one of the smallest labor unions to the biggest. He talked about the need to build collaboration and take care of each other and our own emotional needs because we have a lot of work to do. He ended with expressing the need for community schools.

On the second day of the conference, the workshop sessions covered the theme of "Spring into Action" through the lens of main categories: Awareness, Skills and Capacity. A few workshop titles included Multiraciality in Education, Creating Authentic Ethnic Studies Pathways from High School to College and An Introduction to Anti-Bias Education. During lunch there was a presentation by Jarvis R. Givens, an Assistant Professor of Education and African & African American Studies at Harvard University. He specializes in the history of African American Education and published his first book, Fugitive Pedagogy: Carter G. Woodson and the Art of Black Teaching. Following the workshops, there was a Racial Equity

Affairs Committee (formerly EMAC) Forum and Ethnic Caucus meetings.

On Saturday evening, at the CTA Human Rights Awards Dinner, CTA President E. Toby Boyd recognized the awardees by saying that these "educators are showing us how to tackle our past and present honestly, confront injustice, and educate with integrity and courage". Awardees recognized were: VanCedric Williams, Christina Alaniz, Guadalupe Carrasco Cardona, Telly Tse, Juli Stowers, Vanessa Aranda, Daniel Gallegos, Magret Nunes and the Sacramento City Teachers Association.

On Sunday morning there was a Forum hosted by the Sexual Orientation Gender Identity Issues Advisory Committee followed by a Women's Rights Committee Forum. Also, the LBGTQ+ and the Women's Caucuses met before the last session. In the closing address President Boyd discussed how important the sessions are to a better understanding of our work as educators. He also mentioned the work that educators do beyond their daily work, the importance of the Supreme Court Justice nominee, and the effects of COVID on our educators and students. Lastly, he spoke about the need to continue the fight against vouchers, fight for our minority and LGBTQ+ students and the importance of basic human rights.

and engagement in fossil fuels. Secretary-Treasurer Debra Sheehan reported that our membership increased by 1,009 members since the same time last year and now totals 19,936. members to testify on these bills. Member Ed Foglia testified on SB 868 before the Senate Committee and member Tom Conry testified on AB 1667. In addition to the testimony, CTA/NEA-Retired put together teams to lobby members of the Senate and Assembly Appropriations Committees. Both bills passed easily in their committees of origin, their respective appropriations committees, and the house floors. We'd like to give a big shout out to all our members who participated. Thank you all!

When the bills crossed over to the opposite house, CTA/NEA-Retired once again had members testifying on our behalf. Ed Foglia testified on SB 868 in front of the Assembly PERS Committee and CTA/

NEA-Retired member Georgia Moore (former San Ramon Valley Education Assn member) testified on AB 1667 in front of the Senate PERS Committee. Our bills needed to be out of the Senate and Assembly by the end of August. Governor Newsom has until September 30th to sign or veto the bills.

While these two bills have been a major priority for CTA/NEA-Retired this past year, please don't forget that your nine State Council representatives sit on several of CTA's State Council committees. We have representation on CTA's Retirement, Political Involvement, Civil Rights in Education, State Legislation, Tenure and Academic Freedom, Assessment and Testing, and Student Support Services

committees. And, your representatives are not shy and make sure CTA is aware of retiree voices when debating policy.

An excellent example is the debate that occurred during the May State Council meeting over a New Business Item that would require CalSTRS to divest from fossil fuels. Based on CTA Policy, the CTA Retirement Committee took an oppose position on the NBI. Your representatives on the Retirement Committee debated the issue in committee and on the floor of Council. After debate had ended, State Council voted to support the Retirement Committee's decision and opposed the NBI for fossil fuel divestment.



Superintendent of Public Instruction Tony Thurmond thanked representatives at the the May CTA State Council for recommending his re-election. He said people don't know how hard educators work especially now when systems are experiencing such hard times. He pledged to provide the resources to support educators and prioritize students to help every child recover from the challenges of the pandemic. His very inspiring speech is available on YouTube.
