- Applicant must be <u>claimed as a dependent status</u>* on the member's current year IRS forms. Applicant must be the dependent child of an active, CTA/NEA-Retired or deceased CTA member. This scholarship is not available to spouses of CTA members. *Per IRS regulations.
- 2. Applications must be submitted online by **Friday**, **January 27**, **2023**. A complete application consists of the online application, two recommendation forms and official transcripts.
- High school grade point average should reflect a high unweighted average. College coursework should reflect high academic achievement. Explain any unique circumstance related to medical, physical or emotional difficulties that may have affected the applicant's grades.

 - Educational and personal achievements that reflect academic and/or vocational potential.
- Applications are read in their entirety by the CTA Scholarship Committee. The
 applications with the highest cumulative scores will be recommended as scholarship
 recipients.

Scholarship Awards

- 1. CTA receives approximately 300 400 applications in this category annually. A maximum of 34 scholarships of up to \$5,000 are awarded.

 - One scholarship is provided in Honor of Ruthie Fagerstrom and is awarded to the second highest-scoring applicant.
 - One scholarship is provided in Honor of Susan B. Anthony and is awarded to the third highest-scoring applicant.
 - The Del A. Weber Scholarship, in the amount of up to \$5,000, is awarded to one dependent child of an active member of CTA, CTA/NEA-Retired or deceased CTA member who is attending or attended a continuation high school or an alternative education program.
- 2. Scholarship applicants are notified by mail in May. To receive funds, scholarship recipients will be required to submit an official verification of enrollment for the summer or fall 2023 semester/quarter as:
 - A full-time student in an accredited institution of higher learning; or
 - Registered in an approved credential or degree program in an accredited institution of higher learning.
- 3. Scholarship funds must be used for education-related expenses only.
