RE: Guidelines and Procedures for 2023 NEA Representative Assembly Elections

The CTA Elections and Credentials Committee has compiled the following information to assist local chapters in conducting local delegate elections for the annual NEA Representative Assembly (RA).

STATE AND LOCAL DELEGATE INFORMATION

The 2023 NEA Representative Assembly will be held on July 2-6 in Orlando, Florida. More details to come as they are made available by NEA.

ELECTION BY SECRET BALLOT

The requirement that state and local NEA delegates be declared elected by secret ballot by the NEA membership makes either appointment or election of delegates by the representative governing body of an affiliate impermissible.

An election by secret ballot may be waived and the candidate(s) elected if, following a period of open nominations, the number of candidates is equal to or less than the number of delegate positions to be filled. For example, if a chapter or Service Center Council has five seats allocated to them and there are five (or less) NEA member candidates who submitted declaration of candidacy forms, all five members can automatically be declared elected without going through the process of an election. An affiliate utilizing this provision must have adopted a governing provision or election policy allowing such a practice in advance of the announcement of the election. This election practice will not generate successor delegates unless the nomination process requires candidates for both regular and successor delegate positions.

Since delegates are frequently unable to attend the RA, the local chapter is encouraged to report the names of all individuals receiving votes in the election, including successors. In elections where the number of candidates is equal to or less than the number of delegate positions to be filled, a separate election must be held for successor delegates, unless the nomination process requires candidates for both regular and successor delegate positions. All NEA election requirements apply to the election of successor delegates in the same manner as for delegates.

ELECTION TO MULTIPLE DELEGATE POSITIONS

Members can be nominated to and run for both state and local delegate positions. However, delegates may **NOT** hold both positions. Members elected to both state and local delegate positions are responsible for informing CTA Elections and their local, **in writing**, **no later than April 14, 2023** of the position accepted and the position declined. This notification will release the unused position to a successor delegate and will **relinquish** any claim to the released position.

ETHNIC MINORITY GOAL

Based on the 2020 census figures, California's ethnic minority goal is 60%. This is in keeping with the NEA's policy of achieving ethnic minority delegate representation at least equal to the proportion of identified ethnic minority population within the state.

The California Teachers Association is committed to ethnic minority representation in the California delegation. We need your help so that we can reach our goal at this year's NEA convention. Service Center Council leadership and chapter leaders are asked to encourage all known ethnic minority members to be candidates.

Candidates will have an opportunity to include their ethnic background as part of their biographical sketch, which will not count as part of the 30-word limitation on the *Declaration of Candidacy* form. Please ensure that the race or ethnicity of the delegates and successors is included on NEA's election reporting forms.

IMPORTANT DATES

The CTA Elections and Credentials Committee has established five deadlines on the 2023 CTA/NEA Election Timelines. It is mandatory that these five deadlines are followed:

- 1) **January 31, 2023, 4pm** Deadline for CTA Elections to receive *State Delegate Declaration of Candidacy* forms.
- January 31, 2023 Deadline for chapters to have established timelines for local delegate elections. Local delegate elections <u>must</u> be completed by March 17, 2023.
- 3) April 7, 2023, 4pm Deadline to submit all delegate election results to RA@cta.org. Results must be posted no later than five calendar days following ballot counting.
- 4) **April 14, 2023** Delegates who have been elected to both local and state delegate positions <u>must</u> notify CTA Elections and their local, in writing, by emailing <u>RA@cta.org</u> of the position accepted (delegates may NOT hold both positions).
- 5) **April 21, 2023** CTA Elections to notify local chapters of names of successor state delegates if an elected state delegate chooses to go as a local delegate.

STATE DELEGATE INFORMATION

Declaration of Candidacy forms and Service Center Council office information can be found on the CTA website at www.cta.org. CTA Elections will begin accepting State Delegate Declaration of Candidacy forms on January 5, 2023.

It is the responsibility of each member wishing to run as a state delegate to make sure they have received an automatic confirmation email after submitting their form. <u>Paper copies will NOT be accepted.</u>

RETIRED DELEGATE ALLOCATIONS

A person who is eligible for NEA membership in both the Retired and Active membership categories shall have the option to join the Association as a Retired <u>or</u> as an Active member.

An Active Life member who is eligible for Retired membership may join the NEA as a Retired member while retaining an Active Life membership, provided that during the period of such membership, the individual shall be counted for the allocation of delegate credentials, be eligible to participate in NEA governance, be eligible to receive NEA benefits and services and be treated for all other NEA purposes as a Retired member, as required under NEA Bylaw 2-1d.

HIGHER EDUCATION

Higher Education members are entitled to state delegate representation only through their own Higher Education Service Center Council.

STATE DELEGATE ELECTION TIMELINE

The timeline for NEA RA state delegate elections is included with this mailing. See Attachment "A". This timeline applies to local delegate elections as well.

STATE DELEGATE FUNDING

At the time of this notice, the reimbursement amount (with appropriate receipts) for state delegates is not known. The reimbursement information will be posted on www.cta.org once it is available.

PLEASE NOTE: Declaration of Candidacy forms (for State Delegates, Retired Delegates, Higher Education and ESP Members) are to be filed online at CTA.org only. Click here to file a Declaration of Candidacy form for the State Delegates election (conducted by the CTA Elections and Credentials Committee). Submission window is January 5, 2023 through January 31, 2023 no later than 4pm.

LOCAL DELEGATE INFORMATION

LOCAL DELEGATE ALLOCATION EMAILS

Chapter presidents will receive **two** emails directly from NEA regarding their local delegate allocation. The first email will be sent the week of January 16, 2023 (tentatively), alerting chapter presidents of the upcoming allocation email. The subject line of this alert email will be **NEA RA DELEGATE ALLOCATION NOTIFICATION**. The second email will be sent the week of January 23, 2023 (tentatively), containing the delegate allocation information. The subject line of this email will be **NEA RA ALLOCATION INFORMATION**. Both emails will come from the **RASupport@nea.org**.

LOCAL DELEGATE FUNDING

The local shall determine funding for local delegates. Regardless of the funding amount, the election for NEA RA local delegates must be held in accordance with the requirements stated herein below.

Prior to the election, the local will determine the amount of funding that will be provided to delegates elected to the NEA RA and this information must be included on the ballot. If partial funding is provided, funding will be based on the election results. For example, if four delegates are elected, but funding will only be provided for two delegates, funding will go to the top two candidates with the most votes. If the ballot is waived, the CTA Elections and Credentials chairperson must be contacted through the Governance Support Department for direction on how to determine partial funding.

LOCAL DELEGATE ELECTION REQUIREMENTS

- 1) A chapter or cluster of chapters must follow these requirements when conducting local delegate elections for the NEA RA.
 - a) There must be open nominations. All NEA members are eligible to nominate or be nominated for office.
 - b) Declaration of Candidacy forms must be readily available to members and must state requirements as to time and place of filing. IT IS THE RESPONSIBILITY OF THE CANDIDATE TO ENSURE THAT THIS DOCUMENT IS RECEIVED BY THE DUE DATE.
 - c) No less than 15 calendar days prior to an election, the local chapter shall notify members of the election.
 - d) Candidates must not use any portion of dues money of the local, Service Center Council, CTA or NEA to promote the candidacy.

- e) District email addresses and/or systems shall not be used for campaigning.
- f) All NEA members within the chapter or cluster of chapters shall be eligible to vote.
- g) The time and place of the election must be designated.
- h) Candidates may run as both state and local delegates but must decide which position to accept and notify CTA Elections and local chapter, in writing, **no later than April 14, 2023** of the position selected. This will relinquish all claims the delegate has to the released position.
- i) Elections shall be by secret ballot.
- j) There shall be a provision for write-in candidates.
- k) The election shall be by plurality vote.
- When there is a tie in a plurality election, the following procedure shall be followed:
 - 1. When there is a tie, the ballots shall be recounted.
 - 2. If the result is still a tie, the Elections Committee chairperson shall:
 - (a) Call the candidates (according to the CTA alphabet) and inform them of the tie and that a coin toss shall be used to determine the winner.
 - (b) If the first candidate called wishes to remain in the race, the chairperson shall ask that candidate to choose "heads" or "tails" in the coin toss.
 - (c) The Elections Committee chairperson shall designate the time and place for the coin toss and inform the candidates, who may have an observer present. The observer may be the candidate.
 - (d) The Elections Committee shall note the coin toss on the CTA Official Teller's Report.
 - (e) The Elections Committee shall follow the established procedure in notifying the candidates of the results.
- m) If there is a tie among three or more candidates, contact the CTA Elections and Credentials chairperson through the Governance Support Department at 650.552.5300.
- n) All candidates shall be ranked in order of the number of votes received.
- 2) A chapter or cluster of chapters may waive the requirement for secret ballot election for NEA RA local delegates and candidates declared elected only if the following conditions have been met prior to the election being held:
 - a) The chapter or cluster of chapters has adopted a governing provision or election policy allowing the practice for waiving the NEA RA local delegate elections secret ballot when the number of candidates is equal to or less than the number of delegate positions to be filled.

- b) The period for open nominations shall be no less than 15 calendar days.
- c) This election practice will not generate successor delegates unless the nomination process requires candidates for both regular and successor delegate positions.
- 3) Each ballot shall list names of candidates in the current CTA official alphabet order:

FNUVEMDPRZCHSYOLJAKWXIGBTQ

- 4) The announcement of election results shall be made the next day after the votes are counted.
- 5) The local shall retain all ballots and election records until the expiration of the term to which the delegate was elected.
- 6) Terms for local delegates may range from one to three years. There is no limit on the number of terms an individual may serve as a delegate. The terms may be staggered. If a delegate has been elected to more than a one-year term and they have not yet completed the term, please include their names and the term they are serving on the local delegate election reporting form (directly sent via email from NEA to chapter presidents).
- 7) A successor delegate is the candidate with the next highest votes after the winners have been declared. The successor delegate will automatically be declared a delegate when a vacancy occurs. Only those members reported and certified as a successor delegate are eligible to serve as successor delegates. All candidates shall be ranked in order of votes received.

When the results of the local delegate elections are determined, please complete the election reporting forms, which will be emailed directly to chapter presidents from the NEA (see page 9 herein above Local Delegate Allocation Emails).

The forms must be received by the CTA Elections and Credentials Committee no later than **4pm**, **Friday**, **April 7**, **2023**. Scan and email election paperwork to <u>RA@cta.org</u>.

Please <u>do not</u> send the election reporting forms to the NEA. NEA will only send them back to the CTA Governance Support Department, which will **delay** the processing of your forms.

LOCAL DELEGATE ELECTION TIMELINES

Local CTA chapters are strongly encouraged to follow the same timeline as the state so that elections can be consolidated. Consideration must be given for vacations, spring breaks and year-round school calendars.

- The specific timelines for elections for NEA local delegates shall be determined by each chapter or cluster of chapters, provided that names of delegates are reported to the CTA Elections and Credentials Committee by emailing <u>RA@cta.org</u> no later than **4p.m.**, **Friday**, **April 7**, **2023**.
- 2) The timeline shall include dates for:
 - a) Deadline for receiving *Declaration of Candidacy* forms by members.
 - b) Preparation of ballots: the ballot shall state the name of the office, the term and the name of the candidate(s) who have filed declarations of candidacy within the timeline. The ballot shall include space for a write-in candidate, except in a run-off election.
 - c) Election in chapter.
 - d) Counting of ballots by chapter elections committee.
 - e) **April 7, 2023** is the deadline for receipt of local delegate election results to CTA Elections and Credentials Committee. Scan and email election paperwork to RA@cta.org.
 - f) Delegates who have been elected to both local and state delegate positions must notify the chapter and CTA Elections of the position accepted (delegates may not hold both positions) by **April 14, 2023**.
 - g) Chapter presidents must notify CTA of name of successor local delegate if an elected local delegate chooses to go as a state delegate.
 - h) Challenges to local delegate elections must be filed with the CTA President at ctaelections@cta.org on the official CTA Original Election Challenge Form located in Appendix R of the 2022-2023 CTA Elections Manual within four calendar days after the date the ballots are counted, including any run-off, if necessary. The challenge and all of the requested documentation must be received by the CTA President at cta.org no later than 5pm on or before the fourth day.
 - i) **June 1, 2023** is the deadline for filing an appeal of the state's decision on a challenge with the NEA Credentials Committee.

This means that if a chapter had five seats allocated to them, and there were five (or less) NEA member candidates who submitted declaration of candidacy forms, all five members could be declared elected without going through the process of an election. An affiliate utilizing this provision must have adopted a governing provision or election policy allowing such a practice in advance of the announcement of the election. Your chapter Representative Council must declare by voice vote that the candidate(s) are elected by acclamation. This election practice will not generate successor delegates unless the nomination process requires candidates for both regular and successor delegate positions.

In elections where the number of candidates equals the number of delegate positions to be filled, a separate election should be held for successor delegates. All NEA election requirements apply to the election of successor delegates in the same manner as for delegates.

The requirement that state and local NEA delegates be elected by secret ballot by the NEA membership makes either appointment or election of delegates by the representative governing body of an affiliate impermissible.

The chapter elections committee will prepare a ballot, which will be delivered to you in a quantity sufficient for the NEA members in your building.

 - c. No less than fifteen (15) calendar days prior to an election, the local chapter shall notify members of the election.
 - d. Candidates must not use any portion of the dues money of the local, service center council, state or national level to promote the candidacy.
 - e. District email addresses and/or systems shall not be used for campaigning.
 - f. All NEA members within the chapter or cluster of chapters shall be eligible to vote.
 - g. The time and place of the election must be designated.
 - h. Candidates may run as both state and local delegates, but must decide which position to accept and notify CTA Elections and the local chapter, in writing, **no later than April 8**, **2022** of the position selected. This will relinquish all claims the delegate has to the released position.
 - i. Elections shall be by secret ballot.
 - j. There shall be a provision for write-in candidates.
 - k. The election shall be by plurality vote.
 - I. When there is a tie in a plurality election, the following procedure shall be followed:
 - 1. When there is a tie, the ballots shall be recounted.
 - 2. If the result is still a tie, then the elections committee chairperson shall:
 - (a) Call the candidates (according to the CTA alphabet) and inform them of the tie and that a coin toss shall be used to determine the winner.
 - (b) If the first candidate called wishes to remain in the race, the chairperson shall ask that candidate to choose "heads" or "tails" in the coin toss.

 - (d) The elections committee shall note the coin toss on the CTA Official Teller's Report.

- n. All candidates shall be ranked in order of votes received.
- 8. A chapter or a cluster of chapters may waive the requirement for secret ballot election for NEA RA local delegates and candidate(s) declared elected only if the following conditions have been met prior to the election being held:
 - a. The chapter or cluster of chapters has adopted a governing provision or election policy allowing the practice for waiving the NEA RA local delegates elections secret ballot when the number of candidates is equal to or less than the number of delegate positions to be filled.
 - b. The period for open nominations shall be no less than fifteen (15) calendar days.
 - c. This election practice will not generate successor delegates unless the nomination process requires candidates for both regular and successor delegate positions.
- 9. Each ballot shall list names of candidates in the current CTA official alphabet order:

F N U V E M D P R Z C H S Y O L J A K W X I G B T Q

- 10. The results of the election shall be made known to the members by the local association as appropriate through any procedure that allows the members to obtain the information without unusual effort.
- 11. The local must retain all ballots and election records until the expiration of the term to which the delegate was elected.
- 12. Successor delegates (alternates) shall be elected in the same manner as the regular delegates and must meet the same requirements as regular delegates. Only those members who are certified are eligible to serve as successor delegates.
- 13. Terms for local delegates may range from one to three years. There is no limit on the number of terms, and the terms can be staggered. The term (one, two, or three years) shall be listed on the ballot.

When the results of the local delegate elections are determined, complete the local delegate election reporting forms, which will be emailed to you **from the NEA**. The forms must be submitted no later than **4:00 p.m.**, **April 7**, **2023** to:
