

# ANNOUNCEMENT SUMMER 2023 ELECTION

The CTA Elections and Credentials Committee will conduct an election for Multiple State Council Representative, and At-Large State Council Representative and Alternate open seats/vacancies. Please see page 2 to review the timeline.

### Here are the lists of State Council Representative open seats/vacancies:

### Multiple Electoral, District Q (HE-2, -4, -6) and ESP-2

Nominations for State Council Representative and Alternate shall be conducted according to the Open Nomination procedure. This procedure holds that every eligible CTA member shall have the opportunity to nominate any CTA member who meets the qualifications for office.

Winners for the Multiple Electoral, District Q and ESP State Council Representative seats are determined by **majority** vote. Runners up will become the Alternate.

#### **At-Large State Council Representative and Alternate**

The CTA Board of Directors, upon recommendation of the Representation Committee, recommends the allocation of At-Large State Council members to Service Center Councils.

As set forth in Section III-14.6 of the CTA Elections Manual, eligible candidates must be BIPOC - African American, American Indian/Alaska Native, Asian/Pacific Islander, Hispanic.

ESP members are eligible to run for At-Large State Council Representative seats provided they meet the requirements stated directly above (CTA Elections Manual, Section III-14.6).

Winner(s) for the At-Large State Council Representative and Alternate seats are determined by **plurality** vote.
